#### Schedule / Annexe

#### Purpose Of Corporation / Déclaration d'intention de l'organisation

- 1. TO RELIEVE POVERTY by providing the eligible beneficiary group (below) with temporary residential accommodation, the necessities of life (e.g. food, clean water, clothing, etc), transportation, medical supply and services, security and settlement assistance, etc.
- 2. TO RELIEVE POVERTY by aiding the eligible beneficiary group (below) in the planning and execution of fundraising campaigns, start-up commercial enterprises, regular employment, loans and financial aid, etc.
- 3. TO ADVANCE EDUCATION by facilitating and superintending formal, informal, experiential and skill-specific educational programming (incl. language programs) for the eligible beneficiary group (below).
- 4. TO ADVANCE EDUCATION by maintaining a publicly accessible (virtual) library of documents, information, literature, case studies and other media about the circumstances and challenges faced by the eligible beneficiary group (below).
- 5. TO ADVANCE EDUCATION by consulting and speaking in public, producing video and other presentation material, publishing reports and conducting other activities for public consumption.
- 6. TO ADDRESS AND PREVENT SPECIFIC PROBLEMS FACED BY FAMILIES by providing the eligible beneficiary group (below) with access to technologies for the purposes of research, information gathering, secure communications, etc.
- 7. TO ADDRESS AND PREVENT SPECIFIC PROBLEMS FACED BY FAMILIES by maintaining a real-time operations centre capability to coordinate aid to the eligible beneficiary group (below), monitor and manage crisis situations.
- 8. TO ADDRESS AND PREVENT SPECIFIC PROBLEMS FACED BY FAMILIES by providing agency, observer and messenger services.
- 9. TO UNDERTAKE ACTIVITIES ancillary and incidental to the attainment of the above purposes.
- 10. THE ELIGIBLE BENEFICIARY GROUP is families and children that are in crisis, in need of protection or at risk of being howsoever: (a) separated against their will; (b) kept in intolerable circumstances; (c) subjected to environmental insufficiency; (d) impoverished; (e) excluded from the benefits of society; (f) overwhelmed and overpowered; (g) unable to assert their free will; or (h) stripped of their voice resulting from (a) physical, emotional or sexual abuse; (b) weaponization or failures of the courts, police, government or child protection authorities; or (c) other causes.

# Schedule / Annexe Classes of Members / Catégories de membres

- 1. There shall be two classes of members: Founding Members and Friends.
- 2. FOUNDING MEMBERS: (a) are entitled to vote at all meetings of members; (b) have the option to receive notice of, to attend and to be reasonably heard at meetings of directors; (c) are admitted (and therefore disciplined, terminated, etc) by resolution of the directors on consent of the Founding Members, signified by resolution thereof.
- 3. FRIENDS: (a) are non-voting and have no rights other than those afforded by the Act; and (b) are admitted (and therefore disciplined, terminated, etc) by resolution of the directors.
- 4. Bodies corporate and other "non-human legal entities" may hold membership.
- 5. Membership does not expire.

### Distribution of Property on Liquidation / Répartition du reliquat des biens lors de la liquidation

Any property remaining on liquidation of the Corporation, after discharge of liabilities, shall be distributed to one or more qualified donees within the meaning of subsection 248(1) of the Income Tax Act.

# Schedule / Annexe Additional Provisions / Dispositions supplémentaires

The corporation shall be carried on without the purpose of gain for its members, and any profits or other accretions to the corporation shall be used in furtherance of its purposes. Directors shall serve without remuneration, and no director shall directly or indirectly receive any profit from his or her position as such, provided that a director may be reimbursed for reasonable expenses incurred in performing his or her duties. A director shall not be prohibited from receiving compensation for services provided to the corporation in another capacity.
